WHEREAS, CCDC is committed to serving the community as part of its Community Extension Services;

WHEREAS, the ADOPTED COMMUNITY, in their desire to improve their quality of life, is enthusiastic about innovations that will improve the quality of life among their members.

ON THE PART OF THE CCDC

- Assist the Adopted Community in the conduct of pertinent people empowering activities which may include but not limited to community profiling, needs assessment, development program/project planning, program and project implementation and case analysis;
- Facilitate linkages, partnerships and collaborations of the adopted community with agencies, institutions, organizations that may pave the way to realizing sustainable development in the community;
- Implement policies and programs that enhance people's well-being, promote development and human rights, and promote collective social harmony and social stability;
- 4. Deploy students/employees from the different colleges such as College of Health Education, College of Social Work, College of Teacher Education, College of Business Education and Accountancy, College of Criminal Justice Education, Elementary and Secondary Laboratory School for their practicum services, community extension activities, field practices, practice teaching that are not limited to trainings, legal services, mission activities, community health nursing;
- 5. Monitor on a regular basis the performance of CCDC Adopted Community joint activities.

ON THE PART OF THE ADOPTED COMMUNITY

- Cooperate, provide counterpart efforts, and share available resources to facilitate conduct of every activity of CCDC in the Adopted Community, be it research, sports, educational or other extension programs;
- 2. Support programs of CCDC Students and/or employees by:
 - a. accommodating and fully supporting students and/or employees in the appropriate completion of their activities; and,



- b. helping ensure the safety and/or security of the CCDC students and employees within the duration of their activities within the community;
- 3. Provide documents to show status of pertinent CCDC Adopted Community joint activities; and,
- 4. Assume responsibility of maintaining/sustaining the program after its evaluation.

That this Agreement shall have a term of 3-years, commencing from May 31, 2022 to May 31, 2025 and may be renewed under such terms and conditions as may be agreed upon by both parties. Each party, however, shall have the right to terminate this Agreement for any reason whatsoever, upon prior written notice at least 6 months from termination date.
