

SPONSORSHIP AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This agreement is executed and entered into by and between:

The **CORDILLERA CAREER DEVELOPMENT COLLEGE (CCDC)**, an academic institution, and a non-stock, non-profit corporation duly organized and existing under the laws of the Philippines, with its registered address located at Buyagan, Poblacion, La Trinidad, Benguet, herein represented by its President, **SHERRY JUNETTE M. TAGLE**, and hereinafter referred to as the "**FIRST PARTY**";

-AND-

MISTER GRAND PHILIPPINES-CORDILLERA, an organization promoting the cultural heritage, environmental stewardship and community leadership of the Cordilleran people, with office located at Rm 3C, Amos Building, Km6, La Trinidad, herein represented by its Regional Director, **BELMER G. ELIS**, and hereinafter referred to as the **SECOND PARTY**.

WITNESSETH:

WHEREAS, the **SECOND PARTY** is looking for a venue to hold the Grand Coronation Night of the Mister Grand Philippines-Cordillera, on September 28, 2024 from 6:00pm-9:00pm;

WHEREAS, the **FIRST PARTY** has a gymnasium facility big enough to host the event;

WHEREAS, the **SECOND PARTY** sought the support of the **FIRST PARTY** to sponsor the venue of the coronation night, to which the **FIRST PARTY** acceded provided terms and conditions are met;

NOW THEREFORE, premises considered, the parties hereto agree on the following terms and conditions;

TERMS AND CONDITONS:

1. The first party shall allow the Second Party to use its gymnasium as their venue, **FOR FREE**, except for the following charges:
 - a. Overtime pay for janitors, sound system and led wall operators, who will be required to be on duty from 5pm until the end of the program;
 - b. First party, through the Admirals Park shall cater the food, with fee, for the event organizers and their guests;
 - c. The Second party shall employ CCDC Hotel Management students to serve as workforce in the serving of food; and
 - d. Second party to pay the rent of the use of CCDC's led wall.
2. The Second party shall provide their own garbage bags and shall be responsible to bring-out their own garbage/trash after the event. CCDC practices a "zero-waste" policy to all event users of its facilities.
3. The Second Party shall be responsible for any loss or damage of property incurred by the First Party as a result of the event.

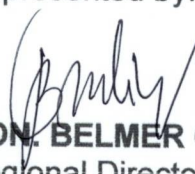

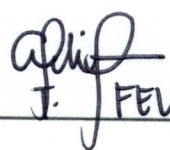
